The mapping was elaborated in order to identify citizens` engagement in policy making both from the perspectives of civil society and public bodies in EaP countries, as they consider to be the major actors in promoting democracy and human rights, the rule of law and sustainable economic and social development. Moreover, high-quality sector reform dialogue can only be achieved through stronger leadership of civil society organizations.

Geographically, the study covers a vast array of civil actors based in Ukraine, Armenia, Azerbaijan, Moldova and Georgia. It includes information concerning identification of organization, focus of organization, name of organization representative, contact information and status of participation in 10th CSF Annually meeting. This information should serve as the basis for creation of EaP CSOs network for further communication. By means of creation of peer-learning and sharing platforms it will be strengthened in order to enhance the role of CSOs in the broader open government agenda in EaP countries.

The mapping gives realistic picture of the Open Government Partnership Initiative implementation and CSOs participation in anticorruption activities in EaP countries. It provides mechanisms of visibility of the CSOs involvement in such processes.

The study should be used while creating a common online social media platform which should serve as a mechanism for all participating CSOs to ensure effective communication. Sharing of best practices, success stories on lessons learned within the EaP CSOs network will contribute to increasing public accountability and civil society`s role in anticorruption initiatives, as well as promotion of Open Government Partnership Initiative implementation in their countries.
